Introduction/Cyflwyniad

After completing an e-assessment, centres can access a Test Report for candidates via e-volve > "Results" tab > "Candidate Report" button.

While the Test Report will not include a final result (mark or grade) it can provide some useful information on Learning Outcomes where the candidate gave a strong performance and areas for improvement. This document looks at the kind of information that can be found in a Test Report and how to interpret it.
