Foundation	For the Foundation qualification, can you mix the building services trade with a construction trade?	There are 6 common units and then 2 selected trade areas. There may be options for centres to run the common units to learners in the same classroom.	Ar gyfer y cymhwyster Sylfaen, allwch chi gymysgu crefft gwasanaethau adeiladu â chrefft adeiladu?	Mae 6 uned gyffredin ac yna 2 faes crefft dethol. Efallai bydd opsiynau i ganolfannau redeg yr unedau cyffredin i ddysgwyr yn yr un ystafell ddosbarth.
Foundation	Does the Foundation need to be completed before the Progression?	The Foundation is designed to be sat and completed prior to undertaking the Progression qualification. Mae'r cymhwyster Sylfaen wedi'i gynllunio fel bod rhaid i ddysgwyr ei astudio a'i gwblhau cyn y gallent ymgymryd â'r cymhwyster Dilyniant. Foundation	What would happen if a centre is not approved for the Foundation qualification? Is there an appeals process?	There isn't an appeals process if centre and/or qualification approval is denied. Centres will receive a copy of the EQA report which will detail why approval has not been granted and outline what actions the centre needs to take before submitting another application. Centres are welcome to submit another application once those actions have been completed.	Beth fyddai'n digwydd pe na bai canolfan yn cael ei chymeradwyo ar gyfer y cymhwyster Sylfaen? Core	How does the Core in Construction and Building Services Engineering (Level 2) qualification fit in? Is it just for learners without employers?	Its primary purpose is to be taken part-time by learners who have secured a Construction or BSE Apprenticeship and not previously completed the Foundation in Construction and Building Services Engineering qualification. This qualification will enable learners to go on to study a range of other Level 2 or 3 Construction and Building Services Engineering courses relevant to their trade interest area.	Beth yw pwrrpas cymhwyster Craidd mewn Adeiladu a Pheirianneg Gwasanaethau Adeiladu (Lefel 2)? Ai dim ond i ddysgwyr heb gyflogwyr y mae hyn?	Mae'r cymhwyster wedi'i anelu at ddysgwyr rhan-amser sydd wedi ennill Prentisiaeth Adeiladu neu Beirianneg Gwasanaethau Adeiladu, ac nad ydynt wedi cwblhau'r cymhwyster Sylfaen mewn Adeiladu a Pheirianneg Gwasanaethau Adeiladu o'r blaen. Bydd y cymhwyster hwn yn galluogi dysgwyr i fynd ymlaen i astudio amrywiaeth o gyrsiau Adeiladu a Pheirianneg Gwasanaethau Adeiladu Lefel 2 neu 3 eraill sy'n berthnasol i'r grefft sydd o ddiddordeb iddynt.

Progression	Will there be online exams for each topic of the Progression qualification?	At progression there will be a specific online multiple-choice examination for each trade area.	A fydd arholiadau ar-lein ar gyfer pob pwnc yn y cymhwyster Dilyniant?	Wrth ddilyn llwybr cymhwyster dilyniant, bydd arholiad amlddewis penodol ar-lein ar gyfer pob maes crefft.
Progression	How can the removal of electrical science/principles from the Level 2 Progression qualification on the Electrotechnical route be justified?	The Level 2 Progression qualifications are not competence-based qualifications, and an individual does not need to complete a Progression qualification as part of the journey to occupational competence. For an individual to be considered occupationally competent they would need to complete the appropriate framework which will include the Level 3 Building Services Engineering - Electrotechnical qualification. The Level 3 qualification will require a learner/apprentice to cover all mandatory occupational standards and content. It is for this reason that the Progression qualifications only need to cover aspects of the knowledge and skills an individual will need to be competent and so consideration needs to be given to which content and skills are most appropriate to include in the qualification to ensure that it is a manageable and engaging 1 year programme of learning/qualification.	Sut mae cyflawnhau cael gwared ar wyddoniaeth/egwyddorion trydanol o'r cymhwyster Dilyniant Lefel 2 ar y llwybr Electrodechnegol?	Nid yw cymwysterau Dilyniant Lefel 2 yn gymwysterau sy'n seiliedig ar gymhwysedd, ac nid oes angen i unigolyn gwblhau cymhwyster Dilyniant fel rhan o'r daith tuag at gymhwysedd galwedigaethol. Er mwyn i unigolyn gael ei ystyried yn gymwys yn alwedigaethol, byddai angen iddo/iddi gwblhau'r fframwaith priodol a fydd yn cynnwys y cymhwyster Peirianneg Gwasanaethau Adeiladu Lefel 3 - Electrodechnegol. Bydd y cymhwyster Lefel 3 yn gofyn i ddysgwr/prentis ymdrin â'r holl safonau galwedigaethol a chynnwys gorfodol. Am y rheswm hwn, dim ond agweddau ar y wybodaeth a'r sgiliau y bydd angen i unigolyn fod yn gymwys ynddynt sy'n cael sylw yn y cymwysterau Dilyniant, felly mae angen ystyried pa gynnwys a sgiliau sydd fwyaf priodol i'w cynnwys yn y cymhwyster er mwyn sicrhau ei fod yn rhaglen ddysgu/cymhwyster blwyddyn sy'n bosibl ac yn ddifyr.
Level 3	What is the timeline for the Level 3? What needs to be covered in year 1, 2 and 3?	The content of the qualification is in the handbook, it all depends on how the centres wish to deliver the content, for example: block release, day release, 6 hour or 8-hour days. There is no set delivery model, but we recommend centres look at the specification of the assessments and deliver those prior to Test 1. Durations of apprenticeships are agreed between the centre, employer and apprentice and this is supported with initial assessments, interview and recognition of learner's prior achievements and experience. Mae'r cyfan yn dibynnu sut mae canolfannau'n dymuno darparu'r cynnwys, er enghraifft: bloc astudio, diwrnod astudio, diwrnod 6 awr neu ddiwrnod 8 awr. Nid oes model darparu penodol, ond rydym yn argymhell bod canolfannau'n edrych ar fanylob yr asesiadau ac yn darparu'r rheini cyn Prawf 1. Mae'r ganolfan, y cyflogwr a'r prentis yn cytuno ar hyd y prentisiaethau, ac mae hyn yn cael ei ategu gan asesiadau cychwynnol, cyfweliad a chydnabyddiaeth o gyflawniadau a phrofiad blaenorol y dysgwr.
Level 3	When are the RPL mapping documents going to be released?	The RPL documents are now complete and can be accessed on the Skills for Wales website under the 'Centre/Qualification documents' tab for each Level 3 qualification.	Pryd fydd y dogfennau mapio RPL yn cael eu rhyddhau?	Mae'r dogfennau RPL bellach wedi'u cwblhau a gellir eu gweld ar wefan Sgiliau i Gymru o dan y tab 'Dogfennau'r Canolfannau/Cymwysterau' ar gyfer pob cymhwyster Lefel 3.

Level 3	What is the assessor's role on site?	The assessor will assess the end project of the apprenticeship.	Beth yw rôl yr asesydd ar y safle?	Bydd yr asesydd yn asesu prosiect terfynol y brentisiaeth.
Level 3	Who ultimately signs off the learner as competent?	There are numerous occasions where progression of the learner is acknowledged, such as employer sign-off and Test 1. However, ultimately the assessor, IQA and then EQA will make those assessment decisions as with current qualifications.	Yn y pen draw, pwy sy'n llofnodi bod y dysgwr yn gymwys?	Mae sawl achlysur lle mae cynnydd y dysgwr yn cael ei gydnabod, fel cadarnhad y cyflogwr a Phrawf 1. Fodd bynnag, yn y pen draw yr asesydd, y Swyddog Sicrhau Ansawdd Mewnol ac yna'r Swyddog Sicrhau Ansawdd Allanol fydd yn gwneud y penderfyniadau asesu hynny yn yr un modd â'r cymwysterau presennol.
Level 3	What happens if the learner can't get the relevant evidence to complete the full Level 3 qualification, do they get a Level 2 qualification?	There is no Level 2 apprenticeship, if a learner cannot gain the evidence this should be identified at sign-up and a more suitable route identified for the learner. Level 3	What will happen to any mature learners who are already on programme?	This doesn't affect mature learners; this is for 16–19-year-old learners and apprentices.	Beth fydd yn digwydd i unrhyw ddysgwyr aeddfed sydd eisoes ar y rhaglen?	Nid yw hyn yn effeithio ar ddysgwyr aeddfed; mae hyn ar gyfer dysgwyr a phrentisiaid 16–19 oed.
Level 3	What happens if a learner decides to change employers part way through?	In terms of the qualification and the work there is no change they will just move over to the new employer. Level 3	Is the AM2 part of the apprenticeship route	The AM2 is likely to be part of an apprenticeship programme but is not part of the qualification.	A yw'r AM2 yn rhan o'r llwybr prentisiaeth?	Mae'r AM2 yn debygol o fod yn rhan o raglen brentisiaeth ond nid yw'n rhan o'r cymhwyster.
Level 3	There is a lot of coordination required by the providers when organising assessments. This could have a financial burden on the Centres, has this been considered?	Planning and coordination of current on-site assessments take a considerable amount of time and cost. The new model will be very similar to the current model regarding coordination and costs that will occur.	Mae angen llawer o gydlynar y darparwyr wrth drefnu asesiadau. Level 3	For Level 3 Apprenticeships is there an opportunity to step-off and re-join at a later date? What will happen if they don't come back and would like to go into Construction?	There will be 2- and 3-year apprenticeships with a Level 3 outcome. An apprentice who leaves part way through their course can re-join at a later date as they can at present. Depending on the time that will have lapsed the apprentice would be interviewed and guidance provided to support the individual. Level 3	What is the difference between Test 1 and Test 2, they both include Level 2 and Level 3 content?	Test 1 is Level 2 content and Test 2 is Level 3 content.	Beth yw'r gwahaniaeth rhwng Prawf 1 a Phrawf 2, mae'r ddua yn cynnwys Lefel 2 a Lefel 3?	Mae Prawf 1 yn seiliedig ar gynnwys Lefel 2 ac mae Prawf 2 yn seiliedig ar gynnwys Lefel 3.

Level 3	For the College Training Programme - what will EQAs look for in the college training? What sort of records will centres need to keep? Attendance/Timetables/Schemes of work/Examples of training activities etc.	Centres will be expected to have Schemes of Work, Lesson plans etc to cover the requirements in the Assessment pack and QM to enable the learner to carry out the trade specific activities which is no different to what is currently delivered. Level 3	The Employer Confirmation Guide and supporting portfolio of evidence -What is the awarding bodies' vision of what should be there, given that the Qualifications Wales review was particularly hard on portfolios of evidence?	The wording of the Employer Confirmation Guide has been updated. The Employer Confirmation Guide is a document for the employer to document that the learner has completed the activities detailed while working for the employer. Level 3	The Level 3 Project Assessment - the content is clear, but what are you expecting in terms of what is and what isn't covered by direct observation? Run through potential timings - where does this sit in the learner journey?	This information is detailed in the Assessment pack for Level 3 project assignment which can be accessed on the Skills for Wales website under the 'Live assessment materials' tab for each Level 3 qualification. Level 3	Experienced Workers - what would their journey look like? Do they need to attend college, other than to sit the on-screen tests?	There is no difference for the experienced worker. Level 3	Where can you get the occupational competency statements for specific courses and trades?	These are in the Employer Confirmation Guides on the Skills for Wales website under the relevant trades which can be accessed on the Skills for Wales website under the 'Centre/Qualification documents' tab for each Level 3 qualification. Level 3	What is in place for potential learners who are time served, suitable for Level 3 direct entry, but has not completed Level 2?	Learners can enter the apprenticeship directly and will complete the Core qualification and the Level 3 Qualification. There are no longer any Level 2 apprenticeships.	Beth sydd ar waith ar gyfer darpar ddysgwyr gwybodus, sy'n gymwys i ddilyn cymhwyster Lefel 3, ond sydd heb gwblhau Lefel 2?	Gall dysgwyr ddilyn y brentisiaeth yn uniongyrchol a byddant yn cwblhau'r cymhwyster Craidd a'r Cymhwyster Lefel 3. Nid oes unrhyw brentisiaethau Lefel 2 erbyn hyn.

Level 3	Our current apprentices only attend college 1 day a week, with this new qualification is there a set number of days required for them to undertake the different stages, for example Foundation or Progression stages?	If a learner starts at 16, they will do the Core qualification (same as Foundation but a single trade) they won't do the Progression as such just the Level 3 apprenticeship qualification. If a learner has already done the Foundation and/or Progression, it will reduce the length or duration of the overall apprenticeship. Level 3	Does the Employer Confirmation Guide have to be completed before the on-site assessment can take place?	It doesn't have to be, but we would recommend this as it follows naturally when the learner has had the experience on-site carrying out the range of activities, it's at that point the Employer Confirmation Guide is signed-off and you as a centre are comfortable the learner has had the appropriate experience to now undertake their project which is the assessment for this qualification. Level 3	Is there any mention of the AM2 in the framework?	AM2 still required for JIB certification.	A oes unrhyw sôn am AM2 yn y fframwaith?	Mae angen AM2 o hyd ar gyfer ardystiad JIB.
Level 3	What level do learners straight from school move on to?	They will sign on an apprenticeship, the apprenticeship contains the Level 3 and the Core. The Core is the same as the Foundation but with only 1 trade area which is the one, they are employed in. The Level 3 qualification then sits alone and includes content mirroring the Progression plus additional.	I ba lefel mae dysgwyr sydd syth o'r ysgol yn symud i?	Byddant yn cofrestru ar brentisiaeth, mae'r brentisiaeth yn cynnwys y cymhwyster Lefel 3 a'r Craidd. Mae'r Craidd yr un fath â'r Sylfaen ond gyda dim ond 1 maes crefft, sef yr un maen nhw'n cael eu cyflogi ynddo.
